PROCESSING OF FRAMEWORK AGREEMENTS AND FRAMEWORK CONTRACTS DURING THE TRANSITION TO THE ELECTRONIC GOVERNMENT PROCUREMENT SYSTEM (e-GPS)

The public procurement and asset disposal system in the country has undergone tremendous reforms to enhance efficiency, transparency, competition and accountability aimed at guaranteeing value for money and effective service delivery. One of the landmarks in public procurement reforms is the development of the Electronic Government Procurement System (e-GPS), pursuant to Section 7(f) of the Public Procurement and Asset Disposal Act, Cap. 412C (the Act). The e-GPS is designed to automate and streamline public procurement processes from planning stage to payment.

The Office of the President and the National Treasury vide circulars Ref: OP/CAB.6/2A and Ref: NT/PPD/1/3/14 Vol. VI dated 5th June, 2025 and 26th March, 2025 respectively, communicated the transition to and roll out of the Government of Kenya's End-To-End Electronic Government Procurement System (e-GPS) from 1st July, 2025.

In light of the above circulars and the need to transition all procurement transactions to e-GPS, all procuring entities are directed in the intervening period and effective from the date of this Circular, to with immediate effect:

- 1. Cease initiation of procurement processes for Financial Year 2025/2026 going forward through use of framework agreements and/or framework contracts;
- 2. Refrain from issuing any awards or entering into contracts resulting from framework agreements and/or framework contracts process for Financial Year 2025/2026 going forward until after the roll out of the e-GPS; and
- 3. Invoke the provisions of Section 63 of the Act on termination and cancellation of procurement proceedings provided that no letters of notification of awards have been issued.

Effective 1st July, 2025, it is expected that all procurements proceedings, including those processed through use of framework agreements/contracts for Financial Year 2025/2026 going forward, shall be carried out through the e-GPS.

For avoidance of doubt, this Circular shall not apply to existing contracts and the Authority shall in due course issue guidelines on existing contracts.

All Accounting Officers are required to note and bring the contents of this Circular to the attention of all officers involved in the public procurement and asset disposal activities within their jurisdiction.

ROLL OUT OF AN END-TO-END ELECTRONIC GOVERNMENT PROCUREMENT (e-GP) SYSTEM FOR THE GOVERNMENT OF KENYA

A. INTRODUCTION

Reference is made to The National Treasury Circular issued on 10th July, 2024 directing all Accounting Officers of Procuring Entities to prepare for a seamless transition to the use of e-GP System (Copy attached). Additionally, His Excellency, the President in his State of the Nation address on 21th November, 2024 directed the National Treasury to roll-out the e-GP system by the first quarter of 2025 and that going forward only procurements undertaken on the system are sanctioned and paid for.

The implementation and use of the e-GP system will result in reduced cost of goods, works and services; increase transparency in procurement processes and practices; improve efficiency in procurement by minimizing the procurement cycle practices; improve efficiency in procurement by minimizing the procurement cycle practices; improve confidentiality, time; maximize value for money; foster accountability; improve confidentiality, integrity and authenticity of transactions between procuring entities and suppliers; integrity and authenticity of transactions between procuring entities and suppliers; treamlining procurement procedures across the government through standardization of processes and practices; and enhance procurement information management that will facilitate procurement planning, monitoring, evaluation and reporting.

The National Treasury has been employing a phased incremental approach to develop, test and pilot the e-GP system as indicated below:

Phase I modules include: Registration (Supplier and Procuring Entity), Annual Procurement and Disposal Plan, e-requisition, e- tender preparation, e-tender submission, e-tender evaluation, e-tender award, e-framework agreement, e. bid security and guarantee management module, contract management, e. Procurement Management Information System, Workflow management.

Phase II modules include: e-Complaints; e-Compliance, e-Appeals, e-Debarment, performance management, Store Management, e-Auctions, e-Catalogues & Marketplace, e-Reverse Auction.

The e-GP system Phase I modules are complete and ready for rollout. The modules have been undergoing testing and piloting from 25th November, 2024 with the following procuring entities:

- The National Treasury: i.
- State Department for Public Service: ii.
- State Department of ICT and Digital Economy: iii.
- Office of Auditor General; iν.
- Ethics and Anti-Corruption Commission: ν.
- Kenya National Highway Authority; vi.
- Kenya Electricity Generating Company: vii.
- Moi Teaching and Referral Hospital; viii.
 - Public Procurement Regulatory Authority; ix.
 - Busia County (Executive): X.
 - Makueni County (Executive) and; xi.
- Elgeyo Marakwet County (Executive). xii.

The above-mentioned pilot procuring entities will effective 1st April, 2025 transition to the e-GP system to process their procurements.

B. e-GP SYSTEM ROLL-OUT

To ensure successful piloting and roll out of the e-GP system, The National Treasury has adopted the use of Training of Trainers (ToTs) model as one of its training methodologies. Dedicated ToTs have undergone an in-depth hands-on training on the e-GP system's functionality and will be training various users from Ministries. Departments and Agencies and Counties (MDACs) on the e-GP system modules as and when required. Additionally, the Kenya School of Government regional campuses (Nairobi, Baringo, Embu, Matuga, Mombasa) have been earmarked as e-GP training centers that will be offering standing classes as well as on-demand training on the e-GP system modules upon request by procuring entities.

The National Treasury has prepared a training programme on the e-GP system Phase I modules for end-users from procuring entities in both the National and County Governments including State Corporations. The training programme will commence on 7th April, 2025 at KSG campuses as per the attached schedule. The targeted e-GP system end-users to be trained on the functionalities and workflow of the e-GP system include the following:

- a) The Head of Supply Chain Management/Procurement Function;
- b) The Head of Directorates/Departments:

c) Supply Chain Management/Procurement Officers:

d) Public Finance Management Officers (Finance, Audit and Accounts);

e) Technical Officers in User Departments;

f) ICT officers; and

g) Legal officers.

C. SUPPLIER REGISTRATION IN THE E-GP PORTAL

Suppliers are required to self- register on the e-GP portal that is accessible through

www.egpkenya.go.ke. Procuring entities are therefore required to notify their registered suppliers on the following:

- Suppliers within Nairobi may visit e-GP offices situated on 6th Floor, Room 622 Treasury Building, Harambee Avenue to receive registration assistance between 9.00 a.m.- 4.00 p.m. Suppliers may also visit The National Treasury desk located in all Huduma Centres during office working hours.
- 3. Supplier Registration Module Manual is available on the e-GP Portal.
- 4. The National Treasury will be organizing weekly supplier registration webinar on Thursdays commencing 11th April 2025 to 30th May 2025. Suppliers will be required to register for training through links provided on www.egpkenya.go.ke under Supplier Training Tab.. Only suppliers who have registered for the training will be invited to the webinar.

D. REGISTRATION OF PROCURING ENTITIES IN THE E-GP SYSTEM

Procuring entities (not in piloting phase) and their user departments will be registered by The National Treasury in the e-GP system. The following information is required to facilitate the registration of a procuring entity:

- 1. Executive order or any other supporting documents establishing the procuring entity
- 2. Organization structure;
- 3. Official contact details (active telephone/mobile number, active contact email, website);
- Address details (postal address, postal code, physical address, country, county, sub-county);
- List of Directorates/Departments/Divisions/Units as established in the organization structure including their abbreviations for ease of identification in the e-GP system;
- 6. IFMIS Budget codes for the Directorates/Departments/Divisions/Units where applicable;
- 7. A letter authorizing/nominating Head of Procurement as the e-GP system Procuring Entity Administrator; and

8. A letter with the following details (Name, Copy of ID, Employee Number, Job title/designation, Active Mobile Number, Active Email), Accounting Officer and Head of Procurement to facilitate their registration

The purpose of this circular therefore is to bring to your attention the following:

- i. That the roll out date for the e-GP system to all Ministries, Departments, Agencies and Counties remains 1st April, 2025. All procuring entities are expected to prepare for transition to the e-GP system by ensuring that there are registered, by providing the above listed requirements to facilitate registration, and that their users are trained on the e-GP system modules.:
- ii. That National Treasury has organized a training program for e-GP system users at Kenya School of Government campuses as per the attached schedule. Ministries, Departments and Agencies and Counties shall nominate officers to attend trainings as per the enclosed program. The National Treasury will meet the participants training costs at the Kenya School of Government while the MDAC's are required to cater for transport and daily subsistence allowances for the nominated officers;
- iii. That MDACs should submit to The National Treasury the particulars of nominated officers (name, designations and job groups of officers, employee number, email address and mobile contacts) who will attend the scheduled trainings by 31st March, 2025. A soft copy of the same should be emailed to info@egpkenya.go.ke; and
- iv. The Judiciary, the Parliament, Independent Offices, State Corporations and Commissions shall be required to plan for a two-week training for at least thirty (30) members of their staff on the e-GP system Phase I modules between April and June 2025 The National Treasury shall be informed of the scheduled training dates and also provide the particulars of officers (names, designations, employee number and job groups of officers, email and mobile contacts) to be trained. A soft copy of the communication to be emailed to info@egpkenya.go.ke.
